TILDESLASH END USER LICENSE AGREEMENT

This end user license agreement ("Agreement") is made between Tildeslash LTD, a company registered in Norway with the organization number 991 505 849 ("Tildeslash") and the end user ("You").

This license applies to the M/Monit Software ("the Software") and any other machine-readable materials including, but not limited to, libraries, source files, header files, data files and documentation provided by Tildeslash under this Agreement. This End User License Agreement does not apply to the Monit software, which is governed by a separate open source or proprietary license.

You agree to and accept the terms and conditions of this Agreement by installing and using the Software.

1. GRANTED RIGHTS

Tildeslash hereby grants You a non-exclusive, non-transferable, limited license (the "License") to use, install and execute one and only one instance of this Software product provided You agree to and comply with any and all conditions in this license.

2. RESTRICTIONS

You must not

- a. Translate, modify, adapt or create derivative works from the Software.
- b. Modify, reverse engineer, disassemble or decompile binary of the Software, or otherwise attempt to derive the code from such portions, save as prescribed by mandatory law.
- c. Sell, rent, lease, distribute or sub-license the Software in whole or in part or modified to any third party.
- d. Distribute the Software sources or make them public available.

3. LIMITATIONS OF LIABILITY

In no event shall Tildeslash be liable for any damages whatsoever, including - but not restricted to - lost revenue or profits or other direct, indirect, special, incidental or consequential damages, even if they have been advised of the possibility of such damages, except to the extent invariable law, if any, provides otherwise.

5. TERMINATION

This Agreement is effective until terminated. You may terminate this Agreement at any time by destroying all copies of the Software.

This Agreement will terminate immediately without notice from Tildeslash if You fail to comply with any provision of this Agreement.

In other cases Tildeslash reserves the right to terminate this Agreement with reasonable notice if the Software is violating or is alleged to violate third party rights.

If this license is terminated for any reason by either party: (1) You are not entitled to a refund of the license fees paid; and (2) You must destroy all copies of the Software.

This license is governed by the Laws of Norway. Disputes shall be settled by Oslo City Court.
